Docent Training Overview

Trail Tales docent training is free and will provide volunteers with the pertinent background and skills they will need to provide knowledgeable interpretive programs. In return, docents are asked to volunteer 30 hours over the next 2 years conducting interpretive programs or providing other program support. The initial 3 days of training will cover local waterfront history, native tribal culture history, ecology, biology and environmental cleanup/restoration work. An additional training day will be devoted to teaching volunteers affective interpretive techniques. Finally, volunteers will have the opportunity to practice what they have learned during 1 or 2 Practice Days scheduled closer to the beginning of the interpretive season.

2012 Docent Training Application

The 2012 Trail Tales Docent Program will offer four days of free interpretive training for volunteers. This includes three days of subject area training (see attached training outline) and a fourth full-day interpretive guide class to develop docent skills. Classes will be held from 9am – 4pm on Friday April 13, Friday April 20 and Friday April 27 at the Seafarers Memorial Park building in Anacortes. The interpretive guide class will be on Friday, May 18th. Pre-launch practice days will be scheduled on Saturday, May 12 and/or May 19 to provide an opportunity for volunteers to team up and hone their skills for the summer docent program.

The Trail Tales Docent program is open to residents of Skagit County and does not require any prior experience. Class size is limited, so get your application in early. Selected applicants will be scheduled for an informal discussion with the program coordinator to ensure they understand the goals of the program and expectations for their volunteer commitment. A background check will be conducted on all applicants prior to being accepted into the program. Applicants under the age of 18 must have the signature of a parent or guardian to participate. ¹ Volunteers should notify the coordinator at the time of application if they will miss any April class (one only allowed) and offer a plan for self-study on the topic. Attendance May 18 is required for all volunteers.
